General Rules

1. **All 4-H, FFA, Scouts, and open class exhibits must be entered and in place by 10:00 a.m. Thursday, unless otherwise stated in departmental rules.**
2. The judge's decision is final on all awards. The superintendent's placing report will be the official record of the judge's decision for premium payouts. The veterinarian's decision will be final.
3. **Appeal Process: Any protest on rules will include the following: Superintendent of Project, Representative from Extension Office, and Extension Council. Their decision is final.**
4. Exhibitors removing exhibits prior to stated checkout time forfeit all premiums and the privilege to participate in any fair activities (including 4-H/FFA Livestock Sale) after the time the exhibit was removed. Superintendent will report any early removal of exhibits to the 4-H Agent
5. Exhibits will be placed into purple, blue, red and white ribbon groups. Champion and Reserve Champion, Grand Champion and Reserve Grand Champion may be awarded where indicated, if quality merits. No awards will be given which are not previously approved by County Fair Board. See special rules for each department.
6. Premiums will be awarded after the County Fair. Premiums are awarded for purple, blue, red, and white. Premiums will not be awarded in the Cloverbud divisions or for Grand Champion, Champion or Reserve Champions in classes. See events section for cash awards.
7. **Conference Judging:** Formal conference judging will be used in as many departments as possible. Members will be advised just prior to the fair as to scheduling and other details. In other departments, 4-H/FFA members are encouraged to hear judge's comments.
8. If an exhibit does not qualify to show in an existing class, it may be exhibited in a class to be determined by the Superintendent and/or Extension Council and Fair Board. To establish a new class, there must be at least three (3) exhibitors.
9. Exhibits at the Reno County Fair are entered and displayed at the risk of the exhibitor. The Reno County Fair Board accepts exhibits and will exercise due care to protect them. However, the Reno County Fair Board cannot accept responsibility for loss or damage due to the conditions imposed by large crowds, the arrangement of the buildings in which displays are housed and the number of exhibits. Exhibitors who have exhibits of great sentimental and/or monetary value should carefully consider whether such exhibits should be exposed to the hazards of the fair.
10. Exhibits will be release after the Awards Luncheon around 2pm.
11. The Reno County Fair Board prohibits **bikes, rollerblades, skateboards, hoverboards and dogs** at the fair. Items will be taken and then can be picked up Monday at 2pm in the Meadowlark Building.
12. No ATV's or UTV's will be allowed on the fair premise without prior approval of the Fair Board. No one under the age of 21 will be allowed to operate ATV's/ UTV's on the fair premises.
13. No alcohol or controlled substances without a prescription will be allowed in or around the exhibit areas.
14. **No items will be sold or booths set up by individuals or businesses on the fairgrounds without an approved and paid for vendor application. Vendor application is \$150.00. Applications are available from the fair board treasurer.**

Judging Time: Following 4-H Foods Judging

1. This contest is open to the general public.
2. Exhibitors may make one entry per division in this contest.
3. Recipe for each product must be typed on a 8 ½ x 11 sheet of paper, stapled to the entry form and taped, stapled, or twist-tied to the product.
4. Exhibits should be in clear plastic food bags, confectionary/bakery boxes, or disposable containers.
5. Each entry must be accompanied by an official entry form. Entry forms are available at the Reno County Extension Office or at www.renocountyfair.com.
6. All entries must be picked up between 3:00pm-4:00pm Thursday or becomes the property of the Reno County Fair Board.

Cookie Jar

“Country Nights & Barn Lights” is the theme for the 2026 Cookie Jar. This is an individual or club/group entry. You do not need to be enrolled in foods to compete in this class. An individual or a group of 2 or more can compete. Use an assortment of cookies in a clear glass, wide mouth attractively decorated jar of 1 gallon capacity. The decorations and jar are not to exceed a height of 15” & width of 15”. Cookies should be visible through at least a total of 50% of the jar and each cookie should be wrapped separately in clear plastic wrap. Jar must be filled with not less than 5 varieties of cookies using all of the following types at least once, Drop Cookies - dough is dropped by rounded or heaping teaspoonful onto baking sheet. Bar Cookies - spread dough in pan, bake and cut. Refrigerator Cookies - dough must be chilled in the refrigerator before baking. Rolled Cookies - dough must be rolled and cut into desired shapes with cookie cutter. Molded Cookies - formed into desired shapes with your hands. Bring a labeled sample cookie wrapped together with plastic wrap of each recipe made. Place all samples in a covered flat box (no need to decorate), so the judges will not need to open the decorated jar. Boxes and sample cookies will not be returned. Remember you need recipes for each type of cookie in your jar. Cookie jar will count 40%, cookies 60%.

Fresh Salsa Contest

Make your favorite salsa. No need for special presentations. May be any type as long as fresh ingredients are used. To ensure the safe acidity of fresh salsa add (1) Tablespoon per pint of bottled lime or lemon juice or 1/4 teaspoon of citric acid per pint. Acid may be added directly to the jars before filling with product. Add sugar to offset acid taste, if desired. All vegetables or fruit must be FRESH or DRIED. No canned items. All entries must be in standard pint canning jars. Salsa MUST be refrigerated at all times that will include transportation to the fair. If entered and feels warm it will not be accepted. Recipe is required. Salsa unclaimed by 4:00 pm the same day will not be returned.

An award of \$25 for Grand Champion and \$15.00 for Reserve Grand Champion will be given.

Decorated Cake Contest—"Country Nights & Barn Lights"

1. Entries will be received on Thursday between 8:00—10:00 am
2. This contest is for amateur bakers and decorators only. Professional bakers/decorators or those who earn a livelihood from baking MAY NOT enter
3. Each contestant may only enter one cake per category (limit one award per category per person)
4. Any cake displaying poor taste will be disqualified. Judges/Fair Committee reserve the right to disqualify entries showing poor taste
5. Design, style, shape is open to any and all types of cake decorating.
6. Cakes must be at least 85% edible and could be cut to confirm
7. Reno County Fair will not be held responsible for damaged, lost, or stolen entries props or containers. Supplies for making the cake are the responsibility of the participant. By submitting your entry, you accept all contest rules and agree to be bound by the judges' decisions which will be final

Judges Criteria: 50% Overall Appearance
25% Creativity
25% Neatness of cake covering and decorations

An award of \$25 for Grand Champion and \$15.00 for Reserve Grand Champion will be given.

Reno County Bake Off

1. Prizes will be awarded in each division.
2. Prizes will be awarded immediately after judging is completed.
3. For food safety purposes, fillings and frosting made from cream cheese, custards or other foods requiring refrigeration will be disqualified and not judged.

Quick Bread Contest

Quick Bread is a term used to describe bread leavened by baking powder or baking soda instead of yeast. Texture should be fine grained, not crumbly. Flavor should be characteristic of ingredients used. Any nuts or fruits should be evenly distributed. Loaves should be baked in standard bread pans 9"x5"x3" or 8"x4"x3", unless designated by an *; then entry may be any size or shape. Only whole loaves will be accepted. Place exhibit on covered, heavy corrugated cardboard one inch larger than item or a sturdy white paper plate, then in a plastic bag.

Entries will be judged on: General Appearance - 25%, Texture - 45%, and Flavor & Aroma - 30%

-Any Loaf Bread

-Fruit Muffin (4 to a plate)

*Coffee Cake

*Biscuits (4 to a plate)

Loaf Bread Contest

- One standard size loaf of bread.

- Majority of flour used in recipe must be white or unbleached

Specialty Bread Contest

- Whole product or 12 rolls

- Majority of flour used in recipe must be white or unbleached

Fruit Pie Contest

- 9" pie or smaller
- Pie must be in an aluminum disposable pie plate
- Cream pies or pies containing eggs, egg whites or milk will **not be** accepted.
- Perishable food items (cream cheese, meats, custards, etc.) will **not be** accepted.

Cakes

Cakes must be made from scratch. Pan size must be specified in the recipe. Include the frosting recipe if frosted. Cakes to be frosted unless otherwise stated. A light drizzle of icing may be used as a garnish and may be used on cakes not requiring frosting. Frosting should cover the whole cake. Cakes must be entered on covered, heavy corrugated cardboard one inch wider than cake, then in a plastic bag or use a clear plastic cake box. Entries will be judged on: General Appearance - 25%, Texture - 50%, and Aroma & Flavor - 25%.

Cookies

Each variety must consist of six (6) to a plate. Cookies must be shown on a sturdy white paper plate and placed in a plastic bag. Entries will be judged on: Flavor - 40%, Texture - 35%, and General Appearance - 25%.

Cash Prizes: 1st, 2nd, 3rd place can be awarded in each class (1st-\$20, 2nd-\$15, 3rd-\$10)
The Anja Miller Baking Award will be awarded to the Overall Champion (**Award \$100**)

Judging Time: Thursday following the 4-H/FFA entries

Check out will be following the 4-H/FFA awards luncheon Monday

1. Read General Rules. Refer to "Food Safety Recommendations for Acceptable Fair Exhibits" (4-H 712 Jan. 2000) will be used as a source for all requirements, to help make informed safe food preservation exhibits. This bulletin is available at the Reno County Extension Office.
2. Open to the general public. All exhibits must have been preserved since previous year's County Fair.
3. No alcohol should be included as an ingredient in food entries. Entries with alcohol in the recipe will be disqualified and not be judged.
4. All products must be preserved using current USDA canning recommendations for processing.
5. Each exhibit must have complete recipe and instruction attached. Recipes must have the exhibitor's name on the paper. Entries without recipes will be dropped one ribbon placing.
6. Entry cards and recipes are to be attached to the entry. Recipes will not be returned.
7. One exhibit per class. Exhibit shall be in clear standard canning jars with matching brand two piece lids. (Use Ball lids on Ball jars/ Kerr lids on Kerr jars etc) Decorative lids are permissible, but fancy padded lids, fabric over wraps or cozies interfere with the judging process and should not be used. Jars must be sealed when entered.

8. Label each jar/container with uniform label (available at Extension Office) placed one inch from base. (Do not cover brand name of jar.) The label must list: Name, Class Number, Division, Product, Canning Method, Processing Time, Pressure (psi). Canned exhibit will not be opened.
9. Sweet spread must be in a half pint or pint jar. All other products must be in a pint or quart jars. Note: 12-ounce canning jars are available. If there is not a USDA recommended process time for a 12-ounce jar, the recommendation for pint jars may be safely used.
10. A Grand Champion and Reserve Grand Champion exhibit will be awarded if merited.

Suggested amount: 1/3 to 1/2 cup, or three or four pieces per exhibit. All meat jerky must be cooked to 160 degrees F before or after drying.

An award of \$25 for Grand Champion and \$15.00 for Reserve Grand Champion will be given.

1. All wheat exhibits shall be produced during the current year.
2. Wheat must have been produced in Reno County.
3. All exhibits shall be of combine run only; samples shall consist of one bag that can be picked up at any Co-op or the Reno County Extension Office
4. Any entry which has been handpicked and/or screened will be disqualified.
5. Entry must be accompanied by a completed official Crop Data Card.
6. Limitation of entries: Each farmer may exhibit one (1) entry per variety up to a maximum of three (3) varieties of wheat grown on exhibitor's or sponsor's farm. Landlord may enter if tenant does not.
7. All wheat varieties will be shown together.
8. Prizes will be awarded as follows: 1st - \$40; 2nd - \$30; 3rd - \$20; 4th - \$10
9. The decision of the judge is final - no appeals will be considered.
10. In case of a tie, premiums will be added together and divided by the number of entries tying.
11. Bags and cards may be picked up during harvest at local elevators or Reno County Extension Office

1. Any resident of Reno County may enter the following classes.
2. Exhibits must be entered and in place by 10:00 a.m., Thursday.
3. All exhibits must be grown by exhibitor with the exception of materials for flower arrangements (Class OC1129).
4. Open class exhibitors may enter a maximum of eight (8) entries in this department. Only one (1) entry per class, except classes (OC1119, OC1123, OC1124, OC1128, OC1129, OC1130, OC1131, OC1132, and OC1135) where more than one exhibit per class may be entered if different vegetable, fruit, herb or flower variety.
5. It is recommended that entries be made on styrofoam plates (except in garden display class). Use string to attach entry card to exhibit.
6. Refer to the publications Exhibiting Fruits and Vegetables, C-405 and Preparing Cut Flowers for Exhibit, 4H-826 (available at Extension Office) as guides in preparing exhibits.
7. The top three exhibits in each class will be given 1st, 2nd, 3rd place ribbons. A Champion and Reserve Champion may be selected from the vegetable (and fruit) and floriculture exhibits. A Grand Champion and Reserve Grand Champion may be selected from the champions, one from the horticulture and one from the floriculture if quality merits.

3. Pure bred and mixed breed dogs are allowed.
4. For each dog, you must provide proof of current vaccinations with your pre-entry or at check-in to show (Photocopy of veterinarian shot record acceptable). Required vaccinations are: Rabies, Distemper, Hepatitis, Parvovirus, and Parainfluenza, and Bordatella. The Rabies vaccination must be administered by a licensed veterinarian. All vaccinations must be current.
5. Dogs entered in the show need be at fair only at time of show. Dogs must be kept on-leash or crated at all times except when competing in "off leash" competition. Dogs are not allowed to run at large or accompany owner anywhere on fairgrounds at any time.
6. Any abuse of dogs on grounds, or in the ring, will result in disqualification by the superintendent.
7. No dogs other than competing dogs shall be allowed at the show.
8. Female dogs in season may not be shown.
9. Any dog with a contagious, communicable or infectious disease or condition, in the judgment of show management or judge, cannot be shown. It must be removed from the show grounds immediately.
10. Any dog fouling the ring will automatically receive a white ribbon. Owners should collect all dog waste in plastic bags and put in trash.
11. Baiting dogs with food or toys will not be allowed.
12. Good sportsmanship shall be observed at all times. The judge's decision is final. Poor sportsmanship may lead to loss of ribbon, class dismissal or disqualification from show as determined by judge and show committee. Any protest should be made in writing to the superintendents.
13. The 4-H classes of the open class dog show are "qualifiers" for the Kansas State Fair 4-H Dog Show. There is no state fair competition for Pre-Novice Obedience or Level 1 of Rally Obedience.
14. See the rules for the regular 4-H dog show within the 4-H/FFA fairbook in order to understand the required qualifying score in obedience, agility or rally obedience.

General Definitions for all Categories:

- The Kansas 4-H Space Tech Rocketry program is designed to allow 4-H members to explore aerospace through rockets of various sizes. Kansas 4-H has adopted the National Association of Rocketry's rules, regulations, and safety guidelines. General Definitions for the categories:
 - As defined by the National Association of Rocketry (NAR), a scale model is "any model rocket that is a true scale model of an existing or historical guided missile, rocket vehicle, or space vehicle." The intent of scale modeling is, according to the NAR, "to produce an accurate, flying replica of a real rocket vehicle that exhibits maximum craftsmanship in construction, finish, and flight performance." (NAR "Pink Book" 50.1 4-1)
 - For the purposes of Kansas 4-H Space Tech a high powered rocket is defined as a rocket that meets any of the following criteria: 2 inches or greater in diameter (not including fins) and taller than 3 feet (36 inches); Weighs more than 3.3125 pounds (53 ounces or 1500 grams) at time of launch; Uses an 'E' engine or larger to launch (2D, 4C, 8B, etc.), The total impulse of all engines used in the rocket is greater than 20.01 Newton -seconds of thrust.
 - Models powered by rocket motors not classified as model rocket motors per NFPA 1122, eg.
 - Average thrust in excess of 80.01 Newtons
 - Contains in excess of 2.2 ounces (62.5 grams) of propellant and are limited to only H and I motor
 - For the purposes of Kansas 4-H Space Tech NO rocket may be launched using engines totaling more than an 'I' impulse engine or 640 Newton-seconds of total thrust.
- NAR refers to the National Association of Rocketry and its governing board.
- All NAR documents, with the exception of the "pink book," referenced herein can be found at <http://www.nar.org>.
- NAR rules for launching and construction of all rockets are assumed to be used by all 4-H Space Tech exhibitors.
- Adult supervision is defined as being under the direct supervision of someone 18 years of age or older
- High power certification is defined as having successfully completed a certification program for high powered rocketry through the NAR and maintaining that certification. This applies to all membership levels in the NAR. Specifically, the "Formal Participation Procedure" for the "Junior HPR Level 1 Participation Program" as outlined by NAR.

General Guidelines for all categories:

- Read General Rules
- Each exhibitor may enter up to four rockets that have been constructed during the current year. To exhibit in this department, the rocket must have been flown. Support rods must not extend past the tip of the highest nose cone on the model. Support rods must remain in the upright position, do not angle. NO model may be submitted on a launch pad.

- Engines and igniters are not permitted with the exhibit and constitute an immediate disqualification. Engines stuck in rockets will result in immediate disqualification. Engines may not be used for display stands even if hollowed out and constitute immediate disqualification. Rocket engines may not join multi-stage rockets together and will result in immediate disqualification. Multi-stage rockets can be displayed without having the stages connected.
- The report that accompanies the rocket must be limited to the 4-H Space Tech Rocket Exhibit Information Form which is glued to a 10" x 13" envelope.
- Plans (or a photocopy) must be placed inside the envelope. This includes original design rockets. If a rocket has been modified structurally, notations need to be given indicating the changes made, either by notations on the Rocket Exhibit Information Form or by placing notes in the plans. One or more photographs of the rocket at the launch site are required. Photographs showing the rocket at the moment of ignition are preferred. Photographs must be mounted on one side of one 8 1/2" x 11" page. There is to be at least 1 page of photos and no more than 5 pages of photos.
- For a rocket entered in the original design classes, describe in the summary how the rocket was tested for stability prior to flying.
- Up to 4 additional pages can be added to the rocketry information pack detailing the test(s) performed to insure stability. 4-H youth are strongly encouraged to provide as much detail as possible.
- The altitude achieved by the rocket is to be determined using a method other than estimation. Examples of accepted methods include altimeters, computer software, range finders, etc. If additional space is needed to show calculations of how the altitude was achieved one additional page may be added to the rocketry information packet.
- Any safety violation noted by the superintendent, judge, or staff will result in a participation ribbon at the judge's discretion.

General Construction Guidelines for all categories:

- Beginner kits with prefabricated fin assemblies are not acceptable and will be given a participation ribbon.
- Plastic snap-together fins and prefabricated fin assemblies that do not require fin alignment are not acceptable and will be given a participation ribbon.
- This rule does not apply to plastic fins that must be manually aligned and does not utilize a fin alignment mechanism, including, but not limited to fin alignment rings or spacing blocks.
- This rule does not apply to fiberglass, Kevlar, extruded foam, composite, or wood fins; especially when used for "through-the-wall" fin attachment techniques that are common in larger rockets.
- In addition, plastic parts for decorative and mechanical purposes (i.e. decorative nozzles and moving landing struts) are not considered fins and can consist of plastic. Decorative nozzles, etc. need to be securely fastened and not pose a safety hazard.
- Rockets are to be properly assembled according to assembly instructions.
- Angles of fins must fall within a plus or minus 2-degree variation using an approved fin alignment guide (such as DGD 031989). An official fin guide is available from www.kansas4-h.org
- Exhibits must be uniformly painted, smoothly finished and have decals applied smoothly. Fins should be rounded or streamlined. Fins and body tubes are to be sealed to eliminate the appearance of body grooves and wood grain. Any seams on plastic parts are to be sanded smooth. The rocket is to be properly assembled. Fins and launch lugs are to be filleted to reduce drag and properly secure them to the model. The nose cone is to fit snugly but still allow for easy removal. Body tubes/airframes/engine mounts can be made from suitable materials, including, but not limited to: reinforced paper, cardboard, phenolic resin, specialized polymer resins, fiberglass, Kevlar, or other suitable structural materials.

- Models may not be judged based on their paint scheme, (colors and placement on the rocket) with the exception of rockets that fit the definition of a “scale model.” These “scale models” may be judged based on the paint scheme. All other rockets may deviate from the suggested paint scheme, allowing the 4-H youth to display maximum creativity in the finishing of their rocket. Under no circumstances is the weight given to the paint scheme to be sufficient enough, by itself, to move the model from one ribbon placing to another.
- Non-standard surfacing (such as textured paint) may be used if directed by the instructions. This includes scratch-built rockets.
- Scale Model Rockets are to be finished and completed with a majority (greater than 70%) of decals.
- “Scale models” may be judged based on their paint scheme. The judge may deduct up to one ribbon placing for not following paint scheme.
- Rocketry Guidelines:
 - Rockets classified as high powered may not be entered in this category.
 - Each rocket must be able to stand freely by itself or be supported by a solid base, not to exceed 4-1/4” thick and 8” square.
 - If the model rocket is greater than 4 feet tall it can be displayed without a base, or displayed parallel to the ground with up to 3 notched blocks not to exceed 4” in height width and depth.
 - All exhibitors must comply with the NAR Model Rocket Safety Code that is in effect as of October 1st of the current 4-H year. However, in the event that there is a modification in this code the Space Tech Action Team may review and implement the modified code.

Original Design Rocket Guidelines (ages 11 and up):

Purpose: To allow for youth to develop their own rockets (model and high powered) in a safe manner that displays maximum craftsmanship.

- Original design rockets cannot be a modification of a pre-existing kit and must be of original design.
- Original design rockets must be designed by the exhibitor(s).
- Original design rockets must include detailed instructions, so that someone could construct the original designed rocket just like a kit purchased at a store. Instructions can be as many pages as needed to convey full and complete construction techniques.
- Original design rocket instructions should not include copies of instructions in part or in whole from existing kits.
- For a rocket entered in the original design classes, describe in the summary how the rocket was tested for stability prior to flying.
- Up to 4 additional pages can be added to the rocketry information pack detailing the test(s) performed to insure stability. 4-H youth are strongly encouraged to provide as much detail as possible.

Alternative Skins (Ages 14 and Up)

• Purpose: Alternative skins are an advanced construction technique that allows the builders of model rockets to display maximum design and creativity in their models. Alternative skins are thin coverings over a supporting skeleton that serve as the finish of a rocket as opposed to painting. Construction and Operating Rules and Guidelines:

- The General exhibit rules for ALL categories apply.
- Use of alternative skins used for model aircraft is permitted on rockets of original design provided adequate provisions are made to prevent the rocket from catching fire during all phases of flight.
- When used in construction these alternative skins should not be used as primary structure for the rocket. The rocket should still be of sound design and construction to insure safety for personnel performing launch activities as well as others who are in the nearby vicinity.

Types of Covering:

- Plastic shrink-type coatings used for radio control model aircraft are permitted. These can be obtained from various manufacturers and hobby suppliers.
- Other types of fabric coverings such as cloth types using coatings for stiffness are permitted as long as all of the rules set forth above are met.

Quality of Finish:

- When the above finishes are used the following judging criteria will apply in addition to those for judging other rocketry divisions;
- Seams and transition areas will be uniform and even when they are needed in the construction.
- Gaps and holes are not permitted in the covering especially where the fins or other stabilizing devices meet the main body of the rocket.
- Omission of these skins from the bottom of the rocket is permissible. Paints and other types of coatings currently used for rocketry may be substituted in these areas.
- Alternative skins in this section may also be used in conjunction with paints on the rocket. However, care shall be taken to ensure that edges of the alternative skins will not peel off in flight

High Power Rocketry Guidelines:

- Purpose: To allow for improved safety and judging of rockets that meet the requirements of 4-H high power rockets.
- Exhibitors must be at least 14 years of age by January 1 of the current year.
- The rules for ALL categories apply.
- In addition to the information packet completed for all rockets, a high-power information form is to be completed and placed inside the information packet. This may be downloaded from <http://www.Kansas4-H.org/>.
- The NAR High Power Rocket Safety Code applies to the construction and launching of all rockets displayed in this division. As such all exhibitors must comply with the NAR High Power Rocket Safety Code that is in effect as of October 1st of the current 4-H year. However, in the event that there is a modification in this code the Space Tech Action Team may review and implement the modified code.
- All rockets in this division are to be launched under adult supervision by the 4-H member who constructed the rocket.
- If a rocket is launched using an engine(s) that has 160.1 ('H' engine or equivalent number of smaller engines) Seconds or larger, adult supervision must be provided by an individual having at least a Level 1 high power certification. The 4-H member should also hold or be attempting to attain their Level 1 high power certification and should include supporting documentation of such (a copy of the Level 1 card is sufficient).
- If according to Federal Aviation Regulations Part 101, a waiver is required to fly the rocket, a copy of that waiver is to be attached to the High-Power Information Form. In the case where the launch was a public event, a substitute for a copy of the waiver is the Range Safety Officers' (RSO's) contact information.
- High Power Rockets may be displayed without a supporting stand. If a supporting stand is used, it is not to exceed 4-1/4" (four and one-quarter inch) thick and 8" square. The exhibitor's name, county or district, and age must be labeled on the base.

Rocketry Educational Exhibits – Posters, Notebooks and Display Boards

- Purpose: To allow 4-H youth to explore rocketry and aerospace outside the bounds of traditional modeling.
- The rules for ALL categories apply.
- Exhibits may not consist of only a rocket but must contain substantial supporting educational material in the form of posters, notebooks, display boards, etc.
- Displays should be creative and showcase something specific you have learned in the Rocketry project during the current 4-H year.
- Follow copyright laws, citing all sources of information in a standard notation on the "4-H Educational Rocketry Exhibit Information Form." Additional pages can be added inside the Information Packet and should be labeled "Citations."

- Educational displays are not to exceed a standard commercial 3' x 4' tri-fold display board. No card

board table exhibits will be allowed. Care should be taken to use durable materials that will withstand fair conditions.

- “Construction Kits” that are part of educational displays must be contained in cases (tackle boxes, sealable containers, etc.) that may not be larger than 1’ X 2’ X 2’ and must have a latch which securely keeps all components contained in the “Construction Kits”. Other components are to adhere to appropriate dimensions as stated elsewhere.
- Rocketry Educational Project notebooks must be organized in a 3-ring binder.
- Educational posters must be no larger than a 22” X 28” poster board.
- Engines and igniters ARE NOT permitted with the exhibit and constitute an immediate disqualification. This is for safety reasons and includes both spent and live engines.
- Exhibitor’s name, county or district, age, and year(s) in project must be tagged or labeled in a prominent location on the educational display, notebook, “Construction Kit,” and/or poster.
- Exhibits should possess the following qualities (in no particular order):
 - o Central theme
 - o What you want others to learn
 - o Be designed and constructed in a manner befitting the exhibit
 - o Be something you are interested in
 - o Be related to model or high-power rocketry
 - o And those characteristics described above.

Beginning: Exhibitor 7-8 years of age

*Class K1820 ---- Rocket made from kit, (without pre-assembled fin units for state fair.) Include plans.

*Class K1821 ---- Rocket designed by exhibitor; not merely a modification of an existing kit – include plans.

Junior: Exhibitor 9-13 years of age

Class K1825---- Rocket made from kit -- include plans.

Class K1826 ---- Rocket designed by exhibitor; not merely a modification of an existing kit – include plans.

Intermediate: Exhibitor 12-14 years old

Class K1830 ---- Rocket made from kit -- include plans.

Class K1831 ---- Rocket designed by exhibitor; not merely a modification of an existing kit – include plans.

Senior: Exhibitor 14 years and older

Class K1835 ---- Rocket made from kit -- include plans.

Class K1836 ---- Rocket designed by exhibitor; not merely a modification of an existing kit – include plans.

Alternative Skins: Exhibitor must be 14 years or older

Class K1840 ---- Rocket designed by exhibitor that uses alternative skins; not merely a modification of an existing kit. Include original plans.

High Power Rockets: Exhibitor must be 14 years or older

Class K1841 ---- Rocket made from kit or original design-- include plans.

Team: Designed to encourage teamwork among individuals and clubs of any age (for state fair it is 11 years and older) to work on a rocket from the initial design to the finished product.

- Read General Rules
- Each exhibitor may enter one robot per class. Exhibit must have been constructed/completed during the current 4-H year.
- Each robot must be free-standing, without the need for additional supports in order to be moved or exhibited.
- Robot dimensions should not exceed 2 feet high, by 2 feet wide, by 2 feet deep. If displayed in a case, the outside case dimensions should not be excessive. The display case should have the exhibitor's information attached to both the lid and cover, as the top part of the case may be separated from the display.
- All electrical components of the robot must be adequately covered or concealed with a protective enclosure. Paper is NOT considered an adequate enclosure or covering for electrical components.
- Robots must be powered by an electrical, battery, water, or solar source. Robots powered by fossil fuels/flammable liquids will receive a participation ribbon. All robots must include an on/off switch for operation. No remote-control devices will be allowed.
- Each robot must be in operable working condition. The judges will operate each robot to evaluate its workmanship and its ability to complete the task determined by the exhibitor.
- Robots must have automated articulated structures (arms, wheels, grippers, pneumatic, hydraulic, etc.). Game consoles that display on a screen are not considered robots and should either be entered in the electronics and renewable energy project. Robots requiring no assembly, just programming, such as Ozobots, are considered computer sciences projects as the skill is focused on the programming and not the construction of the robot.
- Each exhibitor is required to complete the "4-H Space Tech Robotics Exhibit Information Form." This form must be attached to the outside of a 10" x 13" envelope.
 - o For the State Fair, the 4-H member must include a video following their instructions for operation. The video must not be more than 8 minutes long and should be included on the USB Drive.
- The exhibit must include written instructions for operation, construction plans, one page of photographs, and robot programming information, if applicable. This information should be placed in-side the 10" x 13" envelope mentioned above. Robots that include weaponry of any kind will be disqualified.
- Exhibitor's name and county or district must be tagged or labeled in a prominent location on the robot, educational display, notebook and /or poster board.
- Creativity, workmanship, and functionality will be strong criteria in judging the "Robot Designed by Exhibitor" classes.

***Class K1871 ---- Programmable robot made from a commercial (purchased) kit.**

***Class K1872 ---- Robot designed and constructed by exhibitor. The robot must not be a mere modification of an existing robot kit or plan.**

Junior: Exhibitor 9-11 years old

Class K1876 ---- Robot made from a commercial (purchased) kit.

Class K1877 ---- Programmable robot made from a commercial (purchased) kit.

Class K1878 ---- Robot designed and constructed by exhibitor. The robot must not be a mere modification of an existing robot kit or plan.

Intermediate: Exhibitor 12-14 years old

Class K1882 ---- Robot made from a commercial (purchased) kit.

Class K1883 ---- Programmable robot made from a commercial (purchased) kit.

Class K1884 ---- Robot designed and constructed by exhibitor. The robot must not be a mere modification of an existing robot kit or plan.

Senior: Exhibitor 15 years and older

Class K1888---- Robot made from a commercial (purchased) kit.

Class K1889 ---- Programmable robot made from a commercial (purchased) kit.

Class K1890---- Robot designed and constructed by exhibitor. The robot must not be a mere modification of an existing robot kit or plan.

Team: Designed to encourage teamwork among individuals and clubs of any age to work on a robot from the initial design to the finished product.

Class K1894 ---- Robot designed by 2 or more exhibitors, not merely a modification of an existing plan or kit.

Exhibitors in this class will be assigned a task for their robots to perform. The tasks are changed annually. The robot may be a programmable type that is made from a commercial (purchased) kit.

*No State Fair Classes

Open Class Pee-Wee Divisions

PW (F) - Animal Showmanship

1. Pee-Wee's may show a bucket calf, cat, goat, jr. dairy heifer (born after Jan. 1, current year), dog, hog, lamb, poultry (one fowl), or rabbit. Due to safety concerns, Pee-Wee's will not be allowed to show large animals such as horses, steers, heifers & dairy cows.
2. Requirement to show any animal: A Reno County 4-H/FFA member 12 & older enrolled in that project must accompany the animal and child in the ring. If there is a halter lead, the Jr. Leader will be on the end of the lead. If showing species that do not require halters, a Reno County 4-H/FFA member 12 & older must be present in the ring.
3. Animals shown must be owned by exhibitor on the grounds. Pee-Wee's should borrow animals from exhibitor. This is for both safety reasons and due to lack of stalls available during the fair.
4. Show sticks, brushes and combs are not allowed.
5. Lambs will be shown on halters.
6. Very limited use of a hog bat will be allowed.

Note: Decoration of the animal with hats, bows or some form of costume is acceptable if the animal is completely comfortable with the decoration, and it causes no undue excitement for the animal
